The second floor of the town hall is under construction. We're excited about this location because of the foot traffic on the sidewalk—lots of exposure for the entries. There will be people in the tent watching over the entries at all times.

The tent will open up for contestants to set up entries at 4:30pm. See contest schedule, below. Contestants, friends, families, and bidders are welcome to join after the parade until 7:30pm. Categories:

Adult Division (18 years and over at time of contest):

Best Cookies (includes baked goods)
Best Candy

Junior Division (17 years and under at time of contest):

Best Cookies (includes baked goods)
Best Candy

Prizes:

In both Adult and Junior Divisions, the following cash prizes will be awarded to winners in each category:

1st place: \$100

Rules and Guidelines:

Contestants are to provide **2 dozen pieces per entry on separate serving plates:**

One dozen is for judging and sampling by attendees.

One dozen is for the silent auction.

Recipes must be attached to each dozen—one will go on record and one will go with the winning bidder.

All entries must be titled and credited. Credits for the recipe can go to previous generations, but the baker must also be identified.

Contestants can enter as many recipes/entries as they like.

Contestants are encouraged to decorate their plates/platters. Decorations are not to exceed two feet in diameter or two feet in height.

All serving ware and decorations entered in the silent auction will become the property of the winning bidder. Accompanying serving ware and decorations for the sample/judging dozen will be available on site for pick up until 7:30pm on December 1st. Forman Realtors is not responsible for serving ware that is lost or stolen.

All participants in the junior division must have signed parental/guardian consent.

Entries will be photographed and recipes will be recorded both online and in a book for the BW Area Historical Society and the Sunbury Community Library. Contestants and the general public will have the opportunity to acquire each year's book of Sunbury recipes and celebrations.
